OPERATORS MANUAL


ADANGER: Blade can thrust violently away from material it does not cut. Blade thrust can cause amputation of arms or legs. Keep people and animals 50 feet (15 meters)



WARNING: Trimmer line can throw objects violently. You can be blinded or injured. Wear eye and leg protection.



WARNING: Hazard zone for thrown objects. Blade/Trimmer line can throw objects violently. Others can be blinded or injured. Keep people and animals 50 feet (15 meters)



WARNING: Do not use trimmer head as a fastening device for the blade.



WARNING: The blade continues to spin after the throttle is released or, engine is turned off. The coasting blade can throw objects or seriously cut you if accidentally touched. Stop the blade by contacting the left hand side of the coasting blade with material already cut.

Stop coasting blade by contact with cut material.



OPERATOR SAFETY

- Dress properly. Always wear safety glasses or similar eye protection when operating, or performing maintenance on your unit. (Safety glasses are available.) Eye protection should meet the requirements of ANSI Z87.1 and be marked Z87.
- Always wear face or dust mask if operation is dusty.
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. Do not go barefoot or wear sandals.
- Secure hair above shoulder length. Secure or remove loose clothing and jewelry or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- · Being fully covered also helps protect you from debris and pieces of toxic plants thrown by spinning line/blade.
- Stay Alert. Do not operate unit when you are tired, ill, or under influence of alcohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.

 Never start or run the engine inside a closed room or building. Breathing exhaust fumes can kill.
- Keep handles free of oil and fuel.

 Always use the handlebar and a properly adjusted shoulder strap with a blade (see ASSEMBLY).

UNIT/MAINTENANCE SAFETY

WARNING: Stop unit and disconnect the spark plug before performing maintenance (except carburetor adjustments).

- · Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep unit in good working condition.
- · Throw away blades that are bent, warped, cracked, broken, or damaged in any other way. Replace trimmer head parts that are cracked, chipped, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep blade sharp. Keep cutting line at the proper length.
- Use only 0.080" (2 mm) diameter Weed Eatbrand line. Never use wire, rope, string,
- Install required shield properly before using the unit. Use the metal shield for all metal blade use. Use the plastic shield for all line trimmer use.
- · Use only specified blade or trimmer head; make sure it is properly installed and securely fastened.
- Never start engine with clutch shroud removed. The clutch can fly off and cause serious injury.
- Be sure blade or trimmer head stops turning when engine idles.
- Make carburetor adjustments with the lower end supported to prevent blade or trimmer line from contacting any object. Hold unit by hand; do not use the shoulder strap for support.
- Keep others away when making carburetor adiustments.
- Use only recommended Poulan PRO® accessories and replacement parts.
- Have all maintenance and service not explained in this manual performed by your Authorized Service Dealer.

FUEL SAFETY

- Mix and pour fuel outdoors.
- Keep away from sparks or flames.
- Use a container approved for fuel.
- Do not smoke or allow smoking near fuel or the unit or while using the unit.

 • Avoid spilling fuel or oil. Wipe up all fuel
- spills before starting engine.
- Move at least 10 feet (3 meters) away from fueling site before starting engine.
- Stop engine and allow it to cool before removing fuel cap.
- Empty the fuel tank before storing the unit. Use up fuel left in the carburetor by starting the engine and letting it run until it stops.
- Store unit and fuel in area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area to be cut before each use. Remove objects (rocks, broken glass, nails, wire, string, etc.) which can be thrown or become entangled in the blade or trimmer head

- Keep others including children, animals, bystanders, and helpers at least 50 feet (15 meters) away. Stop engine immediately if you are approached.
- Always keep engine on the right-hand side of your body.
- Hold the unit firmly with both hands.
- Keep firm footing and balance. Do not overreach.
- Keep blade or trimmer head below waist level.
- Do not raise engine above your waist.
- Keep all parts of your body away from blade, trimmer head, and muffler when engine is
- Cut from your right to your left.
- Use only in daylight or good artificial light. Use only for jobs explained in this manual.

TRANSPORTING AND STORAGE

- Stop the unit before carrying.
- Allow engine to cool and secure unit before storing or transporting it in a vehicle.
- Empty the fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting the engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so the blade or line limiter cannot accidentally cause injury. The unit can be hung by the tube.
- Store unit out of reach of children.

It is normal for the fuel filter to rattle in the empty fuel tank.

Finding fuel or oil residue on muffler is normal due to carburetor adjustments and testing done by the manufacturer.

WARNING: If received assembled, repeat all steps to ensure your unit is properly assembled and all fasteners are secure.



ATTACHING THE TUBE


NOTE: Illustrations within this section will help in identifying the assembly steps. Be sure to read each section and review the illustrations, before you begin.

NOTE: A drive shaft is located in the center of the tube. Make sure this shaft does not fall out of the tube. Dirt on the shaft will significantly reduce the life of the unit. If this shaft falls out, clean, relubricate, and re-install.

as illustrated. Keep loose at this time, you will tighten them during a later step.




- Some units may include a plastic cover over the end of the tube. If your unit includes any covering, remove the cover at this time.
- Pull about 1/2 inch of the drive shaft out of the inside of the tube.



NOTE: The end of the drive shaft is square. This square end fits inside a square hole in a shaft inside the engine. Look inside the end of the engine and you will see the square hole in the

NOTE: The end of the tube has a groove that aligns with a ridge in the engine opening. Locate the groove and ridge.




- Align the groove in the tube with the ridge in the engine opening. Insert the tube into the
- Firmly push the tube into engine until it will no longer go into the opening.
- Tighten the screws, using one of the hex keys provided with the unit.

ATTACHING THE HANDLEBAR

ADANGER: The barrier portion of the handlebar must be installed as shown to provide a barrier between operator and the spinning blade.


- Locate the decal on the handlebar. This decal includes two arrows. Position the handlebar on the mounting bracket between these arrows.
- Position the bracket cover over the handlebar. Again make sure the handlebar is between the arrows.

• Insert screws and hand tighten only. These screws will be tightened later.



ATTACHING THE CONTROL HANDLE TO THE HANDLEBAR


NOTE: Make sure the wire going to the control handle is routed below the tube and remains on the right side of the handlebar and the tube.



- · Slide handle onto the right side of the handlebar and align the screw hole.
- · Insert screw and tighten securely

NOTE: Make sure the control handle is on the right side of the unit as shown in the illustration below, and the ON/OFF switch is located on the top of the control handle.

- · Adjust the handlebar to the proper position and tighten the two screws you left loose during handlebar assembly. Make sure these screws are securely tightened.
- After attaching the control handle and tightening the handlebar, route the wire from the control handle through the slit in the bottom of the foam grip.



ASSEMBLY OF SHOULDER STRAP

WARNING: Proper shoulder strap and handlebar adjustments before starting the engine are required.

- Try on shoulder strap and adjust for fit and balance before starting the engine or beginning a cutting operation.
- · Insert your right arm and head through the shoulder strap and allow it to rest on your left shoulder. Make sure the danger sign is on your back and the hook is to the right side of your waist.


NOTE: A one-half twist is built in the shoulder strap to allow the strap to rest flat on the shoul-

- · Adjust the strap, allowing the hook to be
- about 6 inches below the waist.
 Fasten the strap hook to the clamp located between the foam grip and the mounting block and lift the tool to the operating position.

CONFIGURING YOUR UNIT

You can configure your unit using a cutting head for grass and light weeds, or a brush blade for cutting saplings and similar size material. Go to the section for the desired configuration and follow the instructions for assembling your unit.

ASSEMBLY INFORMATION -TRIMMER HEAD




NOTE: Remove the blade and metal shield before attaching the plastic shield and trimmer head. To remove blade, push in locking lever and hold. Rotate blade nut until the locking lever falls into one of the grooves in the dust cup. Continue to hold the locking lever. This will keep the shaft from turning while loosening the blade nut. Remove blade nut by turning clockwise. Release locking lever. Remove both washers and blade. To remove metal shield, loosen and remove the four mounting screws. See ATTACHING THE METAL SHIELD and INSTALLING THE METAL BLADE for illustrations. Be sure to store all parts and instructions for future use

ATTACHING THE PLASTIC SHIELD AND TRIMMER HEAD

WARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter which cuts excess line to the proper length. The line limiter (on underside of shield) is sharp and can cut yoù.


- Remove wing nut from shield. Insert bracket into slot on shield.
- Pivot shield until bolt passes through hole in bracket.
- Tighten the wing nut securely. If your unit has a plastic cover over the threads on the threaded shaft, remove the covering to expose the threads.

sure the dust cup is positioned on the gearbox as shown below.



NOTE: Make sure all parts are properly installed as illustrated in the illustration before installing the trimmer head.

- Push in locking lever and hold.
- Rotate dust cup until the locking lever falls into one of the grooves.

ASSEMBLY INFORMATION -BRUSH BLADE




NOTE: Remove the trimmer head and plastic shield before attaching the metal shield and installing the weed blade. To remove the trimmer head, push in locking lever and hold. Rotate trimmer head until the locking lever falls into one of the grooves in the dust cup. Continue to hold in locking lever. This will keep the shaft from turning while loosening the trimmer head. Remove trimmer head by turning clockwise. Release locking lever. To remove the plastic shield, loosen and remove wing nut. Pivot shield to re-lease bracket from slot. See ATTACHING THE

 Before installing the trimmer head, make PLASTIC SHIELD AND TRIMMER HEAD for illustrations. Be sure to store all parts and instructions for future use. Never use the trimmer head with the metal blade installed.

ASSEMBLY OF THE METAL SHIELD

▲ DANGER: The metal shield must be properly installed on the tool anytime the tool is used with the blade. The forward tip of the metal shield helps to reduce the occurrence of blade thrust which can cause serious injury such as amputation to the operator or by-standers. Failure to install the shield in the position shown can result in serious injury to the operator. The length of the shield must be aligned with the length of the tube. The blade is sharp and can cut you. Be sure to wear gloves while working with blades.

- If your unit has a plastic cover over the threads on the shaft, remove the covering to expose the threads.
- Place the metal shield under the gearbox, and align the screw holes.




Insert and thread the 4 mounting screws through the holes of the gearbox and the metal shield. Tighten evenly and securely with the hex wrench provided.

INSTALLATION OF THE METAL **BLADE**


WARNING: Do not use any blades, or fastening hardware other than the washers and nuts shown in the following illustrations. These parts must be provided by Poulan/Weed Eater and installed as shown below. Failure to use proper parts can cause the blade to fly off and seriously but you or others. seriously hurt you or others.

NOTE: When installing the blade, make sure you install it with the correct side facing up (marked on the blade). If you are re-installing an older blade and the writing has worn off, use the following illustration as a guide.




NOTE: The dust cup is located on the gearbox and not in the parts bag. All other fastening hardware mentioned in the following assembly steps is located in the parts bag.

- · Leave the dust cup on the gearbox.
- Install the blade and the retaining washer over the threaded shaft extending from the gearbox. **NOTE**: It may be necessary to remove a plastic protective covering from the threaded shaft before installing these parts.
- Make sure the raised part of the retaining washer is facing the gearbox and the raised area fits into the hole in the center of the blade (see illustration).
- Slide the blade and retaining washer onto
- the shaft of the gearbox. Now place the cupped washer onto the shaft. Make sure the cupped side of the washer is toward the blade.
- Install the blade nut by threading onto the shaft counterclockwise.



NOTE: Make sure all parts are in place as illustrated, and the blade is sandwiched between the dust cup and the retaining washer. There should be no space between the blade and the dust cup or the retaining washer.

- · Push in locking lever and hold.
- Rotate blade nut until the locking lever falls into one of the grooves in the dust cup.



- Continue to hold in locking lever. This will keep the shaft from turning while tightening the blade nut.
- · Tighten blade nut firmly with a wrench.

· Release locking lever.

Turn blade by hand. If the blade binds against the shield, or appears to be uneven, the blade is not centered, and you must rein-

FUEL YOUR UNIT


WARNING: Remove fuel cap slowly when refueling.

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFFTY.

STARTING

HOW TO STOP YOUR UNIT

To stop the engine, move the ON/OFF switch to the OFF position (toward the cutting head).




STARTING YOUR ENGINE

WARNING: The blade or trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

NOTE: A special feature called the "throttle lock" holds the throttle trigger in the depressed position during starting.


Lock throttle trigger into the starting postion by first pressing the lock-out lever on the top of the control handle. While the lock-out lever is depressed, squeeze and hold the throttle trigger.



 Before releasing the throttle trigger, press the lock button. While this button is still depressed release the throttle trigger.

NOTE: This should allow the throttle trigger to remain in the depressed position for starting. You may want to practice this a few times before you first start the unit.

 DO NOT squeeze throttle trigger during starting; otherwise, it will be necessary to reset the throttle lock.



COLD ENGINE STARTING (or warm engine after running out of fuel)

- Rest engine and shield on ground, supporting trimmer head off ground.
- Move the ON/OFF switch to the ON position.
- · Slowly press the primer bulb 6 times.
- Move the choke lever to FULL CHOKE position.
- Set the throttle trigger in the starting position using the throttle lock feature. Keep throttle trigger in the starting position until engine runs smoothly.
- Pull starter rope handle sharply 6 times.
 Move choke lever to HALF CHOKE posi-
- Move choke lever to HALF CHOKE position.
- Pull starter rope handle no more than 6 pulls, until engine runs.
- pulls, until engine runs.

 Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position. Allow unit to run for 30 more seconds at OFF CHOKE before releasing throttle trigger from the starting position. Release throttle trigger by squeezing the trigger and then releasing it.

STARTING A WARM ENGINE

- Move the ON/OFF switch to the ON position.
- Move the choke lever to the OFF CHOKE position.
- Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow instructions in STARTING A COLD ENGINE.

USING YOUR UNIT

OPERATING POSITION



- Extend your left arm and hold handlebar grip with your left hand.
- Hold throttle grip with your right hand with finger on throttle trigger.

- · Keep unit below waist level.
- Keep shoulder strap pad centered on your left shoulder and danger sign centered on your back.
- Maintain full weight of tool on your left shoulder.
- Without bending over, keep the blade or trimmer head near and parallel to the ground and not crowded into material being cut.

OPERATING INSTRUCTIONS FOR USE WITH TRIMMER HEAD

Before trimming, bring engine to a speed sufficient to cut material to be trimmed.

Do not run engine at a higher speed than necessary. The cutting line will cut efficiently when the engine is run at less than full throttle. At lower speeds, there is less engine noise and vibration. The cutting line will last longer and will be less likely to "weld" onto the spool.

If the trimmer head does not turn when the engine is in operation, make sure the drive shaft housing is properly seated in engine shroud.

Always release the throttle trigger and allow the engine to return to idle speed when not cutting.

ADVANCING THE TRIMMER LINE

Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. The line limiter blade (on underside of shield) will cut the line to the proper length.

WARNING: Use only 0.080" (2 mm) diameter line. Other sizes of line will not advance properly and can cause serious injury. Do not use other materials such as wire, string, rope, etc. Wire can break off during cutting and become a dangerous missile that can cause serious injury.

OPERATING INSTRUCTIONS FOR USE WITH BRUSH BLADE

- Blade Thrust is a reaction that only occurs when using a bladed unit. This reaction can cause serious injury such as amputation. Carefully study this section. It is important that you understand what causes blade thrust, how you can reduce the chance of its occurring, and how you can remain in control of unit if blade thrust occurs.
- WHAT CAUSES BLADE THRUST Blade Thrust can occur when the spinning blade contacts an object that it does not cut. This contact causes the blade to stop for an instant and then suddenly move or "thrust" away from the object that was hit. The "thrusting" reaction can be violent enough to cause the operator to be propelled in any direction and lose control of the unit. The uncontrolled unit can cause serious injury if the blade contacts the operator or others.
- WHEN BLADE THRUST OCCURS -Blade Thrust can occur without warning if the blade snags, stalls, or binds. This is more likely to occur in areas where it is difficult to see the material being cut. By using the unit properly, the occurrence of blade

thrust will be reduced and the operator will be less likely to lose control.



- · Cut only grass, weeds, and woody brush up to 2 inches in diameter with the brush blade. Do not let the blade contact material it cannot cut such as stumps, rocks, fences, metal, etc., or clusters of hard, woody brush having a diameter greater than 2 inches. Keep the blade sharp. A dull blade is more
- likely to snag and thrust.


 Cut only at full throttle. The blade will have maximum cutting power and is less likely to bind or stall.
- "Feed" the blade deliberately and not too rapidly. The blade can thrust away if it is fed too rapidly.
- Cut only from your right to your left. Swinging the unit in the same direction as the blade spins increases the cutting action.
- Use the shoulder strap and keep a firm grip on the unit with both hands. A properly adjusted shoulder strap will support the weight of the unit, freeing your arms and hands to control and guide the cutting motion.
- Keep feet comfortably spread apart and braced for a possible sudden, rapid thrust of unit. Do not overreach. Keep firm footing and
- Keep blade below waist level; it will be easier to maintain control of unit.
- Do not raise the engine above your waist as the blade can come dangerously close to your body.
- Do not swing unit with such force that you are in danger of losing your balance.

Bring the engine to cutting speed before entering the material to be cut.

If the blade does not turn when you squeeze the throttle trigger, make sure tube is fully inserted into the engine.

Always release the throttle trigger and allow engine to return to idle speed when not cutting. The blade should not turn while the engine is running at idle. If the blade turns at idle, do not use your unit. Refer to the Carburetor adjustment section or contact your Authorized Service Dealer.

- · Maintain good firm footing while using the unit. Do this by planting feet firmly in a comfortable apart position.
- Cut while swinging the upper part of your body from right to left.
- As you move forward to the next area to cut, be sure to maintain your balance and footina.




WARNING: The operator or others must not try to clear away cut material with the engine running or the blade turning to avoid serious injury. Stop engine and blade before removing materials wrapped around blade or

REPLACING THE LINE

- Press the tab on the side of the trimmer head and twist the lock ring.
- Remove the lock ring and tap button.




- Pull the spool out of the trimmer head. Remove any remaining line.
- Clean dirt and debris from all parts. Replace spool if it is worn or damaged.
- Replace with a pre-wound spool, or replace line using two 20 foot lengths of 0.080 inch (2 mm) diameter Weed Eater® brand line.
- When installing new line on an existing spool, insert 1/16" of the end of each line into the anchoring holes in the bed of the spool.



- With your finger between the lines, wrap the lines evenly and and firmly around the spool in the direction of the arrow on the spool.
- Position the lines in the guide slots.



- Insert the ends of the lines through exit and become a dangerous missile. holes in the sides of the trimmer head.
- Place the spool in the trimmer head.
- · Make sure the lines are not caught between the rim of the spool and the wall of the trimmer head.
- · Reinstall the tap button and lock ring onto the trimmer head.
- · Align the lock ring over the catches on the trimmer head. Push the ring down and turn until the catches lock into place.



Make sure the lock ring is securely fastened by pulling on it and twisting in both direc-

WARNING: All catches must be fastened and the lock tab latched in the lock ring. If installed incorrectly, the lock ring can fly off

Pull line extending from trimmer head.

SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

Replace spark plug yearly with a Champion RCJ-8Y plug; spark plug gap is 0.025 inches.

Ignition timing is fixed, non-adjustable.
