OPERATORS MANUAL

SAFETY INFORMATION ON THE UNIT

DANGER: Never use blades, wire, or flailing devices. This unit is designed for line trimmer use only. Use of any other accessories or attachments will increase the risk of injury.



WARNING: Trimmer line throws objects violently. You and others can be blinded/ injured. Wear safety glasses and leg protec-tion. Keep body parts clear of rotating line.



Keep children, bystanders, and animals 50 feet (15 meters) away. If approached stop unit immediately.

If situations occur which are not covered in this manual, use care and good judgement. If vou need assistance, cor Service Dealer contact your Authorized call or 1-800-554-6723.

OPERATOR SAFETY

- Dress properly. Always wear safety glasses or similar eye protection when op-erating, or performing maintenance, on your unit (safety glasses are available). Eye protection should be marked Z87.
- Always wear face or dust mask if operation is dusty.
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Do not go Always wear foot protection. Stay clear of barefoot or wear sandals. spinning line.
- Secure hair above shoulder length. Secure or remove loose clothing or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- Being fully covered also helps protect you from debris and pieces of toxic plants thrown by spinning line.Stay Alert. Do not operate this unit when
- you are tired, ill, or under the influence of alcohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.
- Never start or run inside a closed room or building. Breathing exhaust fumes can kill. Keep handles free of oil and fuel.

UNIT / MAINTENANCE SAFETY

- Disconnect the spark plug before performing maintenance except carburetor adjustments.
- · Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working condition.
- · Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper length.
- Use only 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope,
- string, etc.
 Install required shield properly before using the unit. Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor adjustments.
- Use only recommended Weed Eater® accessories and replacement parts.
- · Have all maintenance and service not explained in this manual performed by an authorized service dealer.
- **FUEL SAFETY**
- · Mix and pour fuel outdoors.
- · Keep away from sparks or flames.
- Use a container approved for fuel.



- Do not smoke or allow smoking near fuel or the unit.
- Avoid spilling fuel or oil. Wipe up all fuel spills.
- Move at least 10 feet (3 meters) away from fueling site before starting engine.
- Stop engine and allow to cool before removing fuel cap.
- Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage the trimmer head and be thrown causing serious injury.

- Use only for trimming, mowing, edging and sweeping. Do not use for pruning or hedge trimming.
- Keep firm footing and balance. Do not overreach.
- Keep all parts of your body away from muffler and spinning line. Keep engine below waist level. A hot muffler can cause serious burns.
- Cutting with the line on left side of the shield will throw debris away from the operator.

Use only in daylight or good artificial light. TRANSPORTING AND STORAGE

- Allow the engine to cool; secure unit before storing or transporting in vehicle.
- Empty fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by the tube.
- Store the unit out of the reach of children.

SAFETY NOTICE: Exposure to vibrations through prolonged use of gasoline powered hand tools could cause blood vessel or nerve damage in the fingers, hands, and joints of people prone to circulation disorders or abnormal swellings. ASSEMBLY

WARNING: Make sure unit is properly assembled and all fasteners are secure. ATTACHING THE HANDLE

Groove

• Assemble handle to the unit as shown; make sure bottom of handle is seated in the groove in the trigger housing.

NOTE: Adjustment knob must be assembled on the side of the unit opposite the operator's position.

• Pivot handle to a comfortable position. Tighten handle securely.

ATTACHING THE SHIELD

WARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter which cuts excess line. The line limiter (on underside of shield) is sharp and can cut you.

- Remove wing nut from shield.
- · Insert bracket into slot on shield.
- Pivot shield until bolt passes through hole in bracket.
- · Securely tighten wing nut.



FUEL YOUR UNIT

A WARNING: Remove fuel cap slowly when refueling.

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater® brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUÉL SAFETY.

STARTING

HOW TO STOP YOUR UNIT

To stop engine, move ON/OFF switch to the OFF position.

HOW TO START YOUR UNIT



WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

STARTING A COLD ENGINE (or a warm engine after running out of fuel)

- · Set unit on a flat surface.
- Move ON/OFF switch to the ON position.
- Slowly press the primer bulb 6 times.
 Move choke lever to FULL CHOKE posi-
- tion.
- Squeeze the throttle trigger fully and hold through all remaining steps. Pull starter rope handle sharply 6 times.
- · Move choke lever to HALF CHOKE posi-
- tion. · Pull starter rope handle no more than 6
- pulls, until engine runs. Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

STARTING A WARM ENGINE

- Move ON/OFF switch to the ON position. Move choke lever to OFF CHOKE position.
- Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow instructions in STARTING A COLD EN-
- GINE.



OPERATING POSITION



Cut from your right to your left.

TRIMMER LINE ADVANCE

The cutting head advances line automatically. Do not tap head on the ground to advance line. This may break parts and cause cutting head to malfunction.

Upon unit start up, the line will advance automatically to the correct cutting path length. Always keep the shield in place when the tool is being operated.

TWIST-N-EDGE

- Pull the tab toward the engine.
- Twist the tube to the edging position; release the tab.



REPLACING THE LINE

Pre-wound spools offer the most convenient method for replacing line and ensuring optimum performance.

· Replacement spools are color-coded to ensure use of the correct spool with your unit. Be sure to use the same color spool as the existing spool.

NOTE: Always clear dirt and debris from cutting head components when performing any type of maintenance.

- · Hold spool and unscrew cap by turning in
 - the direction shown on top of the cap. Remove line guide ring and spool.



 Use a pre-wound spool or refill spool with line. If using a pre-wound spool, remove tape strip from line and spool.

REFILLING THE SPOOL WITH LINE

WARNING: Use only 0.080" (2 mm) diameter round line. Other sizes and shapes of line will not advance properly and will result in improper cutting head function or can cause serious injury. Do not use other materials such as wire, string, rope, etc. Wire can break off during cutting and become a dangerous missile that can cause serious injury.

 Cut a length of 30 feet of 0.080" (2 mm) diameter round Weed Eater® brand line.



Spool

- Insert one end of line into center cavity of empty spool. Ensure line will feed into spool in the direction shown on the spool (clockwise).
- Continue feeding line into spool, leaving 4 6 inches (10 – 15 cm) unwound from center of spool.

INSTALLING SPOOL WITH LINE

Install replacement spool.Thread line through line guide ring.



Replacement Spool

- Rest guide ring on spool and place line in slot. Allow line to extend 4 6 inches (10 15 cm) from center of spool.
- Ensure line remains in slot while screwing cap on to the shaft. Only tighten cap hand tight!

SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Carburetor adjustment is a complicated task. We recommend that you take your unit to an Authorized Service Dealer. Damage will occur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable.

SPARK PLUG

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is 0.025".
