
OPERATORS MANUAL

SAFETY INFORMATION ON THE UNIT

**DANGER:** Never use blades, wire, or flailing devices. This unit is designed for line trimmer use only. Use of any other accessories or attachments will increase the risk of injury.



WARNING: Trimmer line throws objects violently. You and others can be blinded/ injured. Wear safety glasses and leg protection. Keep body parts clear of rotating line.



Keep children, bystanders, and animals 50 feet (15 meters) away. If approached stop unit immediately.

If situations occur which are not covered in this manual, use care and good judgement. If you need assistance, contact your Authorized Service Dealer or call 1-800-554-6723.

#### **OPERATOR SAFETY**

 Dress properly. Always wear safety glasses or similar eye protection when operating, or performing maintenance, on your unit (safety glasses are available). Eye protection should be marked ANSI Z87.1.

- Always wear face or dust mask if operation is dusty.
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. Do not go barefoot or wear sandals. Stay clear of spinning line.
- Secure hair above shoulder length. Secure or remove loose clothing or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- Being fully covered also helps protect you from debris and pieces of toxic plants thrown by spinning line.
  Stay Alert. Do not operate this unit when
- Stay Alert. Do not operate this unit when you are tired, ill, or under the influence of alcohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.
- Never start or run inside a closed room or building. Breathing exhaust fumes can kill.
  Keep handles free of oil and fuel.

### UNIT/MAINTENANCE SAFETY

- Disconnect the spark plug before performing maintenance except carburetor adjustments.
- Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working condition.
- Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper length.
- Use only 0.080" (2 mm) diameter Poulan/ Weed Eater® brand line. Never use wire, rope, string, etc.Install required shield properly before using the unit.
  Use only specified trimmer head; make
- Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor adjustments.
- Use only recommended Poulan/Weed Eater® accessories and replacement parts.
- Have all maintenance and service not explained in this manual performed by an authorized service dealer.

#### **FUEL SAFETY**

- Mix and pour fuel outdoors.
- Keep away from sparks or flames.
- Use a container approved for fuel.
- Do not smoke or allow smoking near fuel or the unit.
- Avoid spilling fuel or oil. Wipe up all fuel spills.



- · Move at least 10 feet (3 meters) away from fueling site before starting engine.
- Stop engine and allow to cool before removing fuel cap.

## **CUTTING SAFETY**

**WARNING:** Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage the trimmer head and be thrown causing serious injury

- Use only for trimming, mowing, and sweep-ing. Do not use for edging, pruning or hedge trimming.
- Keep firm footing and balance. Do not overreach.
- Keep all parts of your body away from muffler and spinning line. Keep engine below waist level. A hot muffler can cause serious burns
- Cutting on left side of the shield will throw debris away from the operator.
- Use only in daylight or good artificial light.
  Use only for jobs explained in this manual.

#### TRANSPORTING AND STORAGE

- · Allow the engine to cool; secure unit before storing or transporting in vehicle.
- Empty fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by the tube.

Store the unit out of the reach of children.


SPECIAL NOTICE: This unit is equipped with a temperature limiting muffler and spark arresting screen which meets the require-ments of California Codes 4442 and 4443. All U.S. forest land and the states of California, Idaho, Maine, Minnesota, New Jersey, Oregon, and Washington require by law that many internal combustion engines be equipped with a spark arresting screen. If you operate in a locale where such regulations exist, you are legally responsible for maintaining the operating condition of these parts. Failure to do so is a violation of the law. For normal homeowner use, the muffler and spark arresting screen will not require any service. After 50 hours of use, we recommend that your muffler be serviced or replaced by your Authorized Service Dealer.

## ASSEMBLY

- WARNING: Make sure unit is properly assembled and all fasteners are secure. ADJUST AND SECURE THE HANDLEBAR
- Lift handlebar to upright position



Rotate handlebar/clamp counterclockwise toward engine until clamp falls into groove of clamp base.




- · Place the handlebar in a comfortable operating position.
- Retighten handlebar by turning clamp knob clockwise until handlebar is secure and stationary in clamp base (clamp knob can not be overtightened).

#### ATTACHING THE SHIELD

AWARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line. The line limiter blade (on underside of shield) is sharp and can cut you.

- · Remove wing nut from shield.
- Insert bracket into slot on shield. Pivot shield until bolt passes through hole in bracket.
- Securely tighten wing nut onto bolt.



## FUEL YOUR UNIT

#### **WARNING:** Remove fuel cap slowly when refueling.


This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater® brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.

## STARTING

#### HOW TO STOP YOUR UNIT

To stop the engine, push and release the en-gine STOP switch. The switch will automati-cally return to the ON position. Wait 5 seconds before attempting to restart unit to allow switch to reset.

#### HOW TO START YOUR UNIT



**WARNING:** The trimmer head will turn while starting the engine. Avoid any con-tact with the muffler. A hot muffler can cause serious burns.


#### STARTING A COLD ENGINE (or a warm engine after running out of fuel)

· Set unit on a flat surface.

- Slowly press the primer bulb 6 times.
  Move choke lever to FULL CHOKE position.
- Squeeze the throttle trigger fully and hold through all remaining steps.
- Pull starter rope handle sharply 6 times.
- Move choke lever to HALF CHOKE position.
- Pull starter rope handle no more than 6 pulls, until engine runs.
- Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

#### STARTING A WARM ENGINE

- Move choke lever to OFF CHOKE position.
- Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow instructions in STARTING A COLD EN-GINE.



#### **OPERATING POSITION**



Cut from your right to your left.

### **ADVANCING THE CUTTING LINE**


Advance line by tapping the bottom of the cut-ting head lightly on the ground while engine is running at full speed. The metal line limiter blade attached to the shield will cut the line to the proper length.

#### **REPLACING THE LINE**

- · Remove spool by firmly pulling on tap button.
- Clean entire surface of hub and spool.
- Replace with a pre-wound spool, or cut two lengths of 12-1/2 feet of 0.080" (2 mm) diameter Poulan/Weed Eater® brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
- Insert ends of the lines about 1/2 inch (1 cm) into the small holes on the inside of spool.





- Wind the line evenly and tightly onto the spool. Wind in the direction of the arrows found on the spool.
- Push the lines into the notches, leaving 3 to 5 inches (7 - 12 cm) unwound.
- Insert the lines into the the exit holes in the
- hub as shown in the illustration.
- · Align the notches with the line exit holes.
- Push spool into hub until it snaps into place.
- Pull the lines extending outside of the hub to release the lines from the notches.

#### **REPLACING THE CUTTING HEAD**

- Push in locking lever and hold.
- Rotate dust cup until the locking lever falls into one of the grooves.



- Continue to hold in locking lever. This will prevent the shaft from turning while removing and installing trimmer head.
- Remove trimmer head by turning clockwise.
- Thread replacement trimmer head onto the shaft by turning counterclockwise. Tighten until secure.
- Release locking lever.

## SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

### CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Carburetor adjustment is a complicated task. We recommend that you take your unit to an Authorized Service Dealer. Damage will occur if you turn the needles beyond the limiter stops.

#### **IGNITION TIMING**

The ignition timing is fixed, non-adjustable. **SPARK PLUG** 

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is 0.025".
