



· Assemble handle to the unit as shown; make sure bottom of handle is seated in the groove in the trigger housing.



 Pivot handle to a comfortable position. Tighten handle securely.

ATTACHING THE SHIELD

WARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line to the proper length. The line limiter blade (on underside of shield) is sharp and can cut you.

- Remove wing nut from shield.
- Insert bracket into slot as shown.
- Pivot shield until bolt passes through hole in bracket.
- · Securely tighten wing nut onto bolt.



FUEL YOUR UNIT

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater® brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.


STARTING

HOW TO STOP YOUR UNIT

To stop the engine, push and release the engine STOP switch. The switch will automatically return to the ON position. Wait 5 seconds before attempting to restart unit to allow switch to reset.

HOW TO START YOUR UNIT





WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

COLD ENGINE STARTING (or a warm engine after running out of fuel)

- Set unit on a flat surface.
- Slowly press the primer bulb 6 times.
 Move choke lever to FULL CHOKE posi-
- Squeeze the throttle trigger fully and hold through *all remaining steps*.
 Pull starter rope handle sharply 6 times.
- Move choke lever to HALF CHOKE position.
- Pull starter rope handle no more than 6 pulls, until engine runs.
- Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

STARTING A WARM ENGINE

- Move choke lever to OFF CHOKE position.
- Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow instructions in STARTING A COLD EN-GINE.

USING YOUR UNIT

OPERATING POSITION



Cut from your right to your left.

ADVANCING THE CUTTING LINE

Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. A metal blade attached to the shield will cut the line to the proper

TWIST-N-EDGE


- · Pull the tab toward the engine.
- Twist the tube to the edging position; release the tab.



REPLACING THE LINE

- · Remove spool by firmly pulling on tap but-
- · Clean entire surface of hub and spool.
- Replace with a pre-wound spool, or cut a length of 20 feet of 0.080" (2 mm) diameter Poulan/Weed Eater® brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
- Insert one end of the line about 1/2 inch (1 cm) into the small hole on the inside of spóol.





- Wind the line evenly and tightly onto the spool. Wind in the direction of the arrow found on the spool.
- Push the line into the notch, leaving 3 to 5 inches (7 12 cm) unwound.
 Insert the line into the the exit hole in the hub
- as shown in the illustration.
- · Align the notch with the line exit hole.
- Push spool into hub until it snaps into place.
- Pull the line extending outside of the hub to release it from the notch.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Carburetor adjustment is a complicated task. We recommend that you take your unit to an Authorized Service Dealer. Damage will occur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable.

SPARK PLUG

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is 0.025".
